CONTRACT FOR WATER SERVICE CONNECTION

KNOWN ALL MEN BY THERE PRESENTS:

This **CONTRACT**, made and executed by and between **NORZAGARAY WATER DISTRICT**, with office address located at the 1639 P. Dela Merced Street, Poblacion, NorzagarayBulacan, hereinafter referred to as the **FIRST PARTY**

- And -

Mr./Mrs./Ms. _____ Filipino, of legal age, Single/ married and residing at _____ hereinafter referred to as the **SECOND PARTY**

- WITNESSETH -

WHEREAS, the **SECOND PARTY** is desirous of applying for water service connectionand the **FIRST PARTY** is willing to facilitate the same.

NOW THEREFORE, for and in consideration of the foregoing, the parties hereby agree subject to the following terms and condition.

1. That the **SECOND PARTY** grants and advances in full the cost of:

- a. Service Connection Fee Php _____

- 2. That the **FIRST PARTY** shall have the exclusive right to determine the size of water meter and to select the meter location/relocation, which should be outside the perimeter fence of the **SECOND PARTY**, approximately five (5) meters away from the water mains, for easy access during meter reading and maintenance works;
- 3. That the **SECOND PARTY** shall allow the **FIRST PARTY** to enter his premises for meter reading, inspection of water pipes and fixtures, determine the existence of leakage and defects, calibration of water meter and disconnection service and all other related undertakings;
- 4. That the **SECOND PARTY shall** pay the water bills on or before its due date otherwise, a penalty charge of 10% will be added to the unpaid water bills. Delinquent bills unpaid for 5 days after due date will be subjected to disconnection. The **FIRST PARTY** by virtue of this contract is hereby given the right to disconnect the water service connection even without prior notice;
- 5. That the **SECOND PARTY** shall be held liable if the water meter will be found tampered, with destroyed seal, obstructed and enclosed such that it cannot be readily read when inspected, lost or intentionally damaged or rendered non-functional due to the acts of the **SECOND PARTY** or by any known or unknown third persons. In the event of failure of the water meter to register the accurate amount of water consumed, the **SECOND PARTY shall be charged the average of his latest three (3) monthsconsumption**;

6. That the further selling of water under this contract is strictly prohibited and the **SECOND PARTY** is not allowed to extend or transfer water supply to another party or property without prior approval of the **FIRST PARTY**;
7. That the **SECOND PARTY** shall strictly observe and abide by the rules , regulations and policies imposed by the **FIRST PARTY**;
8. That non-compliance with, or violation of any terms and conditions of this contract by the **SECOND PARTY** shall entitle the **FIRST PARTY** to terminate this contract and/or disconnect his water service connection without prior notice; and
9. The **SECOND PARTY** shall be primarily responsible for taking care of the installed water meter. In case the same is stolen or damaged he/she shall be responsible for the replacement of the water meter. Only accredited and duly calibrated water meter will be accepted by the **FIRST PARTY** as replacement.
10. That NorWD retains full ownership of the service connection.
