- The Government of the Republic of the Philippines has received financing from the Asian Development Bank (ADB) toward the cost of the Water District Development Sector Project. Part of this financing will be used for payments under the contract named above. Bidding is open to Bidders from eligible source countries of the ADB.
- The **Norzagaray Water District** (the Employer) through the Local Water Utilities Administration (the "Procurement Agent"), invites sealed bids from eligible Bidders for the **design and construction of Septage Treatment Plant** ("the Facilities").
- 3 Open Competitive Bidding National will be conducted in accordance with ADB's <u>Single-Stage: Two-Envelope</u> procedure and is open to all Bidders from eligible source countries as described in the Bidding Document.
- 4. Only eligible Bidders with the following key qualifications should participate in this bidding:

Historical Contract Non-Performance

Non-performance of a contract did not occur as a result of contractor default since 1 January 2016.

Financial Situation

- Historical Financial Performance: As a minimum, the Bidder's net worth for the last year calculated as the difference between total assets and total liabilities should be positive.
- Average Annual Turnover: Minimum average annual turnover of PhP67 Million calculated as total certified payments received for contracts in progress or completed, within the last three (3) years.
- Financial Resources: The Bidder must demonstrate that its financial resources, less its financial obligations for its current contract commitments meet or exceed the total requirement for the Subject Contract of PhP8.35 Million

Construction Experience

- Contracts of Similar Size and Nature: Participation as a contractor, JV partner, or subcontractor, in at least two contracts that have been successfully or substantially completed within the last ten (10) years (or Projects completed after 1 January 2011 will only be considered) and that are similar to the proposed contract, where the value of the Bidder's participation under each contract exceeds PhP27 Million. The similarity of the Bidder's participation shall be based on components given in the Employer's Requirements.
- Experience in Key Activities: a minimum experience in the last ten (10) years for the following:
 - Detailed Engineering Design of septage treatment plant with at least 10 CMD capacity;
 - Constructed at least five (5) completed stand-alone septage treatment plants for an LGU/GOCC;
 - At least five (5) years of experience operating and maintaining a stand-alone septage treatment facility as a service provider for LGU/GOCC;
 - Built the process system design (primary treatment, secondary treatment, and tertiary treatment processes) in the bid in at least one (1) facility and have been operational for at

- least one (1) year;
- Constructed at least one stand-alone septage treatment facility that has complied to the DAO 2016-08 standards for at least twelve (12) months;
- Provide a Spare Parts Availability Certificate for the major equipment in the facility; and
- Built their proposed process system design, with the technology and equipment installed in tandem in at least one (1) existing facility together and proven functional by running for at least one (1) year.

The qualification criteria are more completely described in the Bidding Document.

- 7. The Employer will hold a Pre-Bid Conference on 19 May 2021 at 2:00 P.M. (Manila Time). Pre-bid may be conducted in person, face-to-face, through videoconferencing, webcasting, or similar technology, or a combination thereof.
